## SHADES OF SUCCESS - ISSPA

#### Establishment:

- In the Year 1956, GOI imposed more than 100% Excise Duty on Paints and 7 Paint Manufacturers came together to make Representations to GOI. Protested against this unbearable high duty and this group was then known as Indian Small Scale Paint & Allied Association was (Born).
- The first 20 years the managing committee worked to address the many issues regarding the shortage of raw material specially alkyd resin requirement.

#### Achievement:

- In 2013, the Government of India imposed anti-dumping duty on white cement. India had 2 major companies who were manufacturing white cement and they were also manufacturers of cement putty. The small and medium putty manufacturers were not able to compete as they had to buy white cement from them. ISSPA represented the grievances to the GOI and explained the unfair practices, the companies should stop producing putty or else the trade doors should be opened to all . Putty Manufacturers got the relief and import trade was opened anti-dumping duty was removed.
- Our association has been exchanging its views with the Ministry on this issue for almost 15 years and said that lead metal is not directly involved in the production of our paints. Because only micrograms of lead is found in the production of paint, whereas there are many products in India in which lead is found in abundance such as water pipelines, children's school pencils, lipstick and vermillion for women's, idols of God etc. We had many other examples but following the advice of WHO our association cooperated with the government and made our paint industries aware of the new technology and developed new technologies for the production of decorative paints. It was invented so that our industries do not face any problems.
- After 61 years, GOI amended the taxation system in India by introducing GST in 2017. ISSPA members were hit by this classification of paints as a Luxury Product. Paints was classified under Luxury category and attracted 28% GST. This was the biggest hit to this sector. GST Raw materials input credit setoff on most paints manufactured was 8% and ISSPA members had to pay Cash input of 20% on Value of Paints sold. This would have resulted in closure of few hundred manufacturers as they are small and cannot infuse such large sums for doing business. After strong and effective representation to Finance Ministry and GST Council by Central and all Regions (Nation Wide), ISSPA Parivar. Paint Industry to get relief in 6 months and such fast response from Government of India to Paint Industry by giving GST Tariff reduction on Paints from 28% to 18%.
- Besides this ISSPA participates in various Nation International Coating Exhibitions, ISSPA has its own in house magazine "Paint News" which gives lots of information of our industry.

ISPPA is representing on various forums safeguarding the interest of small and medium scale paint manufacturers.
